

# **01 INTRODUCTION**

This addendum provides updates to the 2006 St Lucia Site Development Plan (SDP).

#### 02 PURPOSE OF THIS ADDENDUM

This addendum seeks to provide minor updates to the content of the 2006 SDP so that it more accurately reflects the current and known future state of the campus, including large projects and developments.

This addendum should be considered as an interim document which will lapse upon completion of a comprehensive master planning and engagement process which will update the UQ St Lucia Campus Master Plan.

# **03 NEED FOR REVIEW**

The St Lucia Campus is a large, highly complex, and continually evolving entity. The ever changing needs of students, a competitive education and research environment, and the changing nature of the city that surrounds it, all demand that, from time to time, adjustments to the Site Development Plan are required.

These adjustments set out below are not significant departures from the intent of the adopted SDP, but rather updates that reflect the actual delivery of projects over the preceding period as well as making allowances for currently planned development projects.

## 04 APPROVAL FRAMEWORK

The Queensland Government Department of Public Works granted a Community Infrastructure Designation (CID) to the University of Queensland – St Lucia on 20th April 2000. The CID certificate of designation was granted subject to four conditions. Pertinent to the Site Development Plan, condition 1 states:

"The University's Site Development Plan, as approved by the senate after a process of community consultation and consideration of the overall urban form of the campus, shall be used as a guide for all development proposals"

It is noted that the initial SDP for the St Lucia Campus was developed in 1972 and updated in 1989 and 1996, prior to the CID. However, following the CID, the University prepared its new SDP, which was approved by Senate on 30th November 2006 following a process of community consultation. This document fulfilled the requirements of Condition 1 of the Certificate of Designation. This document has since been used as a guide for all development proposals on campus. The scope and limitations of the SDP are set out in Section 1.04 of the document and it is stated that *"It is expected that continuous re-evaluation and refinement of the detailed development will occur as specific program requirements are defined. The plan is not a "blueprint" to be rigidly adhered to and systematically pieced together. It is a guide for the general intentions".* 

Within this context the SDP will be required from time to time to adequately reflect detailed development proposals and large projects that meet with the general intent of the SDP. Previous legal advice to the University indicates that it is able, via its Senate, to make minor amendments to its SDP to ensure it remains a current reflection of the current needs and form of the campus.

## 05 COMMUNITY CONSULTATION AND ENGAGEMENT

- The University is committed to ensuring its planning and development processes are informed by appropriate consultation, engagement and communication programs and activities. This approach recognizes it is the University's responsibility to keep all stakeholders informed about issues, strategies or plans that may affect them and provide opportunities to inform and guide decision making where relevant.
- The University is in regular communication with local residents, businesses and stakeholders regarding development projects which may have impact. During April May 2015, the University undertook a program of community consultation on a revised master plan for the St Lucia Campus. This process involved a number of opportunities to engage with the project, including targeted interviews, physical displays, community information stalls, a project website, e-newsletter, online survey, written submissions and a telephone information line. The findings from this process, together with other submissions and communications subsequently received and considered by the University have informed the preparation of this addendum.
- In accordance with Condition 3 of the Community Infrastructure Designation, the University will ensure "specific public consultation processes be established for large projects which have the potential to impact on our neighbours".
- Further, "a detailed stakeholder and community engagement program will be implemented as part of the comprehensive master planning process of a revised St Lucia Campus Master Plan".

# 06 SCHEDULES // GENERAL

The next sections of the addendum set out the amended drawings and figures, which reflect principally the following alterations to the SDP:

- " Campus Community: Projections for student numbers (EFTSL) which have been exceeded in the current plan and so have been updated to reflect current and projected numbers;
- Student Housing and Child Care Project: The Walcott Street Student Housing Project and associated relocation of the Childcare Centre to a site on or near the Keith Street car park are not fully reflected in the SDP and so key plans have been updated to reflect the current development intent;
- " Car Parking: The current parking facility being constructed beneath the playing fields on Sir William McGregor Drive is not currently reflected in the SDP and so has been added to the relevant drawings.


FIGURE (h): Indicative Development Plan


Unifying theme: Created by the framework of the landscaped park, broadly identified by the sweep of lawns and belt of trees following the line of the river, the soft edged lakes and the groups of trees.

Particular theme: Created by the precincts, the small spaces between and around the built form surrounding the original sandstone faced buildings. Each precinct can develop its own landscape character.

Integrated theme: Created by the remnant trees of the eucalypt forest interpenetrating the campus from the neighbouring area, softening the demarcation line between the campus and the neighbouring residential community.








FIGURE (r): Public Domain Strategies - Great Court District




FIGURE (u): Public Domain Strategies - West District


